AUCTION NOTICE

The Directorate of Research is having four (04 Nos.) farm ponds of approximate dimensions 30x 30x20 mt which are presently being used for irrigation of nursery plants and other farm operations at Model Farm. Fingerlings (fishes) of Minor carp/Rohu/Silver carp etc. were dropped in these ponds which have now grown up and ready for angling. It has been planned to outsource the management of these live fishes through public auction for a period of three months from the date of award letter. The **successful bidder shall maintain the fishes by providing feed in these farms during contract period**. Accordingly, the **bidder shall quote per kilogram rate** of their angling during the contract period.

Therefore, the sealed bids for the auction of live fishes available in four ponds at Mode Farm of this Directorate are invited through post or in person on or before **14.07.2025 (Monday) at 11.15 AM** in the Committee Room, Directorate of Research, UH&F, Nauni, Solan which shall be **opened on same day at 11.30 AM in the Committee Room** in presence of the bidders by the committee.

The interested persons/bidders/firms may visit the ponds and inspect the fishes on any working day during office hours before the day of auction. The bidders have to drop their bid/offer in prescribed format (copy enclosed) in the tender drop box which is available in the office of undersigned. The bidders shall have to deposit a sum of **Rs.10,000/-** (Rupees Ten Thousand) only as **Earnest Money** before the start of auction, which will be refunded to the unsuccessful bidders immediately after completion of bid process. However, the Earnest Money shall be refunded to successful bidder after completion of the contract otherwise the same shall be forfeited.

The successful bidder shall sign a contract agreement with the undersigned to abide by the instructions issued from time to time by the Government/University. The fish angling has to be completed during office hours in presence of the officer/official of this Directorate and ensure there should not be any damage to University property.

The auction committee will have the right to reject any/all the bids without assigning any reason or may cancel the auction process if the required bidders are not available or for any technical reasons notices by the committee. Other terms and conditions will be announced at the time of auction.
