Cover 2 : Shall contain BOQ/financial bids, where contractor will quote his offer for each item.

3. **Submission of Original Documents** : The bidders are required to submit (a) Original demand draft towards the cost of bid document and (b) Original bid security/earnest money deposit (EMD) in shape of FDR duly pledged to EE(D) UHF Nauni and other technical documents in O/o the undersigned as the specified in key dates on tender opening date, failing which the bids will be declared non responsive. **Only those contractors can compete in this tender with certification (Affidavit in original with name of work mentioned in it) that they have not more than two or more contract at a time each of more than ten lakhs or more in any HPPWD or other Govt. /Semi Govt. in hand.**
4. **Bid Opening detail**: The bids shall be opened on 11.02.2025 at 11.10 AM in the office of the Executive Engineer (D) UHF Nauni Solan by the authorized officer/officials. In their interest the tenderer are advised to be present alongwith original documents at the time of opening of tender. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
5. **Other details can be seen in the bidding documents.** The Officer inviting tender shall not be held liable for any delay due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid update, the employer shall not be liable for any information not received by the bidder.
