"ORDER"

WHEREAS, in pursuance of the judgment dated 06.02.2025 passed by the Hon'ble Supreme Court of India in Civil Appeal No. 1595 of 2025 arising out of SLP (Civil) No. 23016 of 2023, titled *State of Himachal Pradesh & Others versus Surajmani & Others*, all similarly situated employees of this University were granted work-charge status from the date of completion of eight years of continuous service on daily wage basis, in compliance with the directions issued by the Hon'ble High Court of Himachal Pradesh in various cases.

AND WHEREAS, the Principal Secretary (Finance) to the Government of Himachal Pradesh, vide letter No. Fin(C)B(15)-14/2025 dated 04.04.2026, issued certain clarifications/instructions regarding the benefits admissible to employees who have been granted work-charge status in pursuant to court directions.

AND WHEREAS, this University, vide Office Order No. UHF.Regr.Rectt.3-41/2026/-2874-2943 dated 30.04.2026, adopted the aforementioned instructions of the State Finance Department and incorporated the clarifications/instructions prescribed therein with directions that the work-charge status granted to Class-III and Class-IV employees of the University shall be regulated in accordance therewith.

AND WHEREAS, the Hon'ble High Court of Himachal Pradesh in its CWP No. 8937 of 2026 titled *Surender Kumar & Others versus State of H.P. & Others* vide order dated 04.04.2026, has stayed the operation of the communication dated 04.04.2026 issued by the Principal Secretary (Finance) to the Government of Himachal Pradesh. A similar relief has been granted by the Hon'ble High Court of HP in catena of cases of this University filed by the other petitioners against this office order dated 30.04.2026

NOW, THEREFORE, in compliance with the interim order passed by the Hon'ble High Court of Himachal Pradesh in the aforesaid writ petition, the Office Order No. UHF.Regr.Rectt.3-41/2026/-2874-2943 dated 30.04.2026 and the conditions/instructions incorporated in last paragraph of Office Order No. UHF.Regr.Rectt.3-41/2026/-2945-3005 dated 30.04.2026 regarding governance of benefit of work-charge status with certain parameters prescribed in State Finance Department's clarification dated 04.04.2026 are hereby kept in abeyance pending the final adjudication by the Hon'ble High Court of HP.
