The sealed bids are invited for the auction of the Apple Fruit Crop for the year 2026 at Krishi Vigyan Kendra, Shimla at Rohru. Interested bidders may submit their sealed bids either by post or in person **on or before 25.07.2026 up to 11:30 AM**. The bid shall be submitted in the prescribed format (enclosed) and dropped in the Tender Box kept in the office of the undersigned. The sealed envelope must clearly bear the name and complete address of the bidder and be super scribed with "Bid for Auction of Apple Fruit Crop – 2026". The bids will be opened on **25.07.2026 at 2:30 PM** by the Auction Committee in the presence of the bidders who wish to remain present. Interested bidders may inspect the apple orchard on any working day before the auction with the prior permission of the undersigned. Each bidder shall deposit an Earnest Money Deposit (EMD) of ₹20,000/- (Rupees Twenty Thousand only) in the prescribed manner. The EMD of unsuccessful bidders shall be refunded without interest after the completion of the auction process. The successful bidder shall deposit 50% of the bid amount immediately on the same day after acceptance of the bid, and the remaining 50% before commencement of harvesting of the apple fruit crop. The Auction Committee reserves the right to accept or reject any or all bids without assigning any reason. The Committee also reserves the right to cancel or postpone the auction if sufficient bids are not received or for any administrative or technical reasons. Other terms and conditions, if any, shall be announced at the time of the auction.
