OFFICE ORDER

In view of the prevailing financial constraints being faced by the University, it has been decided that no remuneration/honorarium shall be paid to the faculty members and other staff of the University involved for conducting training programmes, workshops, orientation programmes, faculty development programmes, refresher courses, or any other similar academic or training activities.

This restriction shall, however, not apply to external experts/resource persons engaged from outside the University, who shall continue to be paid remuneration/honorarium in accordance with the approved norms and applicable rules.

It is further clarified that any amount received, sanctioned, or payable towards remuneration/honorarium for University faculty members and other staff involved in connection with such programmes or activities shall be deposited directly in the saving account No. 65031154928 being operated in the SBI, Khaltoo (Nauni). The amount so deposited shall form part of the University's funds and shall be utilized for University purposes in accordance with the applicable financial rules and with the approval of the competent authority.

Furthermore, the concerned Coordinator/Principal Invigilator to ensure adequate provision for remuneration and honorarium by increasing at least 20% while submitting any project proposal to external funding agency(s) in future. Failing to make such provision shall render the concerned Coordinator/PI responsible for any financial implications arising therefrom.

All Deans, Directors, Heads of Departments/Centres, Coordinators, Drawing and Disbursing Officers, and all other concerned officers are requested to ensure strict compliance with these instructions. Any deviation from these directions shall be viewed seriously. This order shall come into force with immediate effect and shall remain in force till further orders.

This issues with the prior approval of the Hon'ble Vice-Chancellor.
