



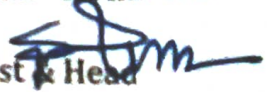

**Auction Notice**

The sealed bids for the auction of Apple Fruit crop at main farm and PCDO farm (except trees marked "Out of Auction") of RHRSS & KVK Lahaul & Spiti-II (Tabo) for the year 2026 are invited through post or in person on or before 18/09/2026 at 10.30 AM at RHRSS & KVK Lahaul & Spiti-II (Tabo). **The bidder has to drop his/her bid offer in prescribed format (Copy enclosed) in the tender drop box in the office of undersigned.** The bidder must write his/her name and address on the sealed bid and the word **"Quotation for Apple Crop"** on the top of sealed envelope. The bid shall be opened by the committee on same day i.e. on 18/09/2026 at 11.00 AM at RHRSS & KVK Lahaul & Spiti-II (Tabo) in the presence of the bidders.

The interested bidders may inspect the apple crop by visiting the apple orchard on any working day with the prior permission of the undersigned. The interested bidders participating for the auction should deposit an earnest money amounting to Rs. 1,00,000/- (Rupees One Lakh) in cash/DD payable to "The Senior Scientist and Head, Krishi Vigyan Kendra, Tabo" at SBI, Tabo for apple fruit crop, which will be refundable to the unsuccessful bidders. The successful bidder will have to deposit the 50% of the bid on the same day through DD payable to "The Senior Scientist and Head, Krishi Vigyan Kendra, Tabo" at SBI Tabo or through online mode in the A/c No. 38325986898, IFSC No. SBIN0006987 of Sr Scientist and Head, KVK Tabo. The remaining 50% needs to be deposited within one week or before harvesting of crop, whichever is earlier. The reserve price has been kept at Rs. 28.0 Lakh only. If the highest bidder fails to deposit the money, then his earnest money will be forfeited. Further, committee retains the right to give auction to next bidder or reject the auction. The committee will have the right to reject any/all bids without assigning any reason or may cancel the auction process if the required bidders are not available during auction or quoting less bid than the reserve price or on any technical reasons/grounds noticed by the committee. 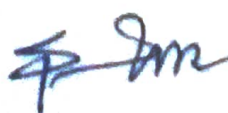

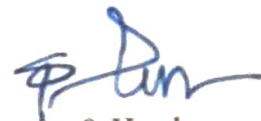

In view of the above said terms and conditions are accepted the interested bidder/ general public are requested to participate in the said auction on the scheduled and time as mentioned above.



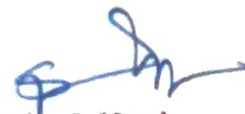
